



OFFICIAL PROMOTION RULES

The promotion begins on August 29, 2016. Entries must be received by September 18, 2016 (hard copies must be returned by September 16, 2016). Promotion is void where prohibited. By entering, each entrant accepts and agrees to be bound by these promotion rules.

2. Eligibility. No purchase necessary to enter or win. The prize consists of the following: One (1) "recycled" vehicle of Conner Brothers' choosing will be awarded in "AS-IS" condition. The value will depend on Conner Brothers' judgment. The estimated retail value of the vehicle will be between \$2,500 and \$15,000.

5. The recipient will be selected based on various criteria, including but not limited to impression of the completed nomination form essay. A panel from Conner Brothers will decide who will receive the "Recycled Ride". One (1) recipient will be selected by the panel.

All DMV fees, taxes and "full coverage" insurance associated with vehicle are the sole responsibility of the recipient. The recipient will maintain "full coverage" insurance on vehicle during their ownership. The vehicle will have decals of the Conner Brothers Collision Center/Recycled Rides, vendors and employee name on it. If the recipient wishes, Conner Brothers will remove all decals at no cost to recipient after 90 days. Sponsors reserve the right to substitute another vehicle at their discretion.
